What is the Caribbean Growth Forum?

THE NEED

Built on a shared sense that stimulating private sector-led **growth is not the responsibility of governments alone.**

Collective action, involving a **range of national stakeholders through public-private dialogue** to:

- catalyze a home-grown development agenda
- ensure that government priorities reflect societal aspirations
- ensure that recommendations have social buy-in
- provide accountability mechanisms that commit governments to deliver

The Caribbean Growth Forum was launched in June 2012 to catalyze such collective action.

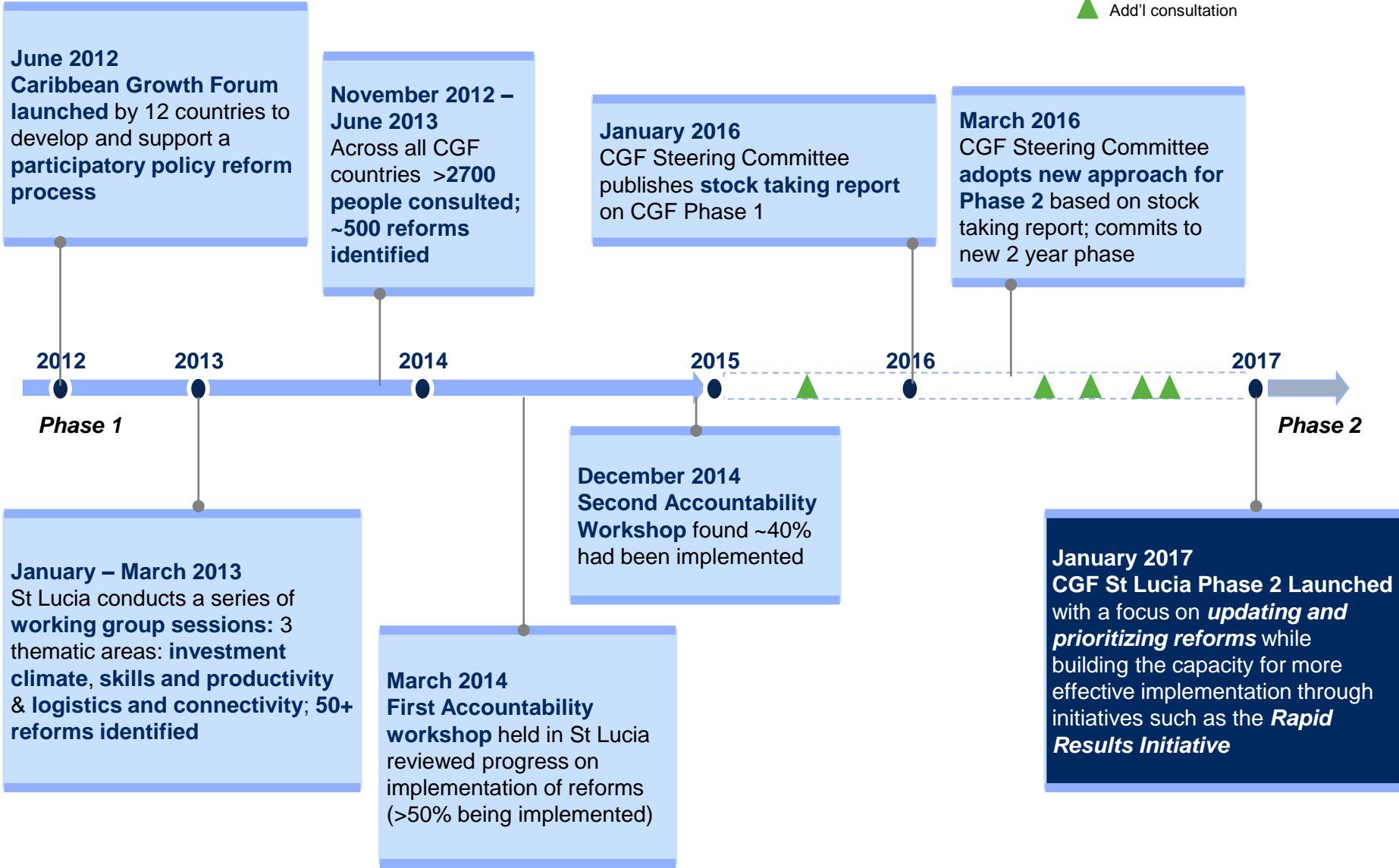
THE INITIATIVE

 - Skills & Productivity
2. Engages and sustains the participation of Caribbean citizens using public-private dialogue;
3. Fosters knowledge sharing to better inform and influence the private sector-led growth agenda.

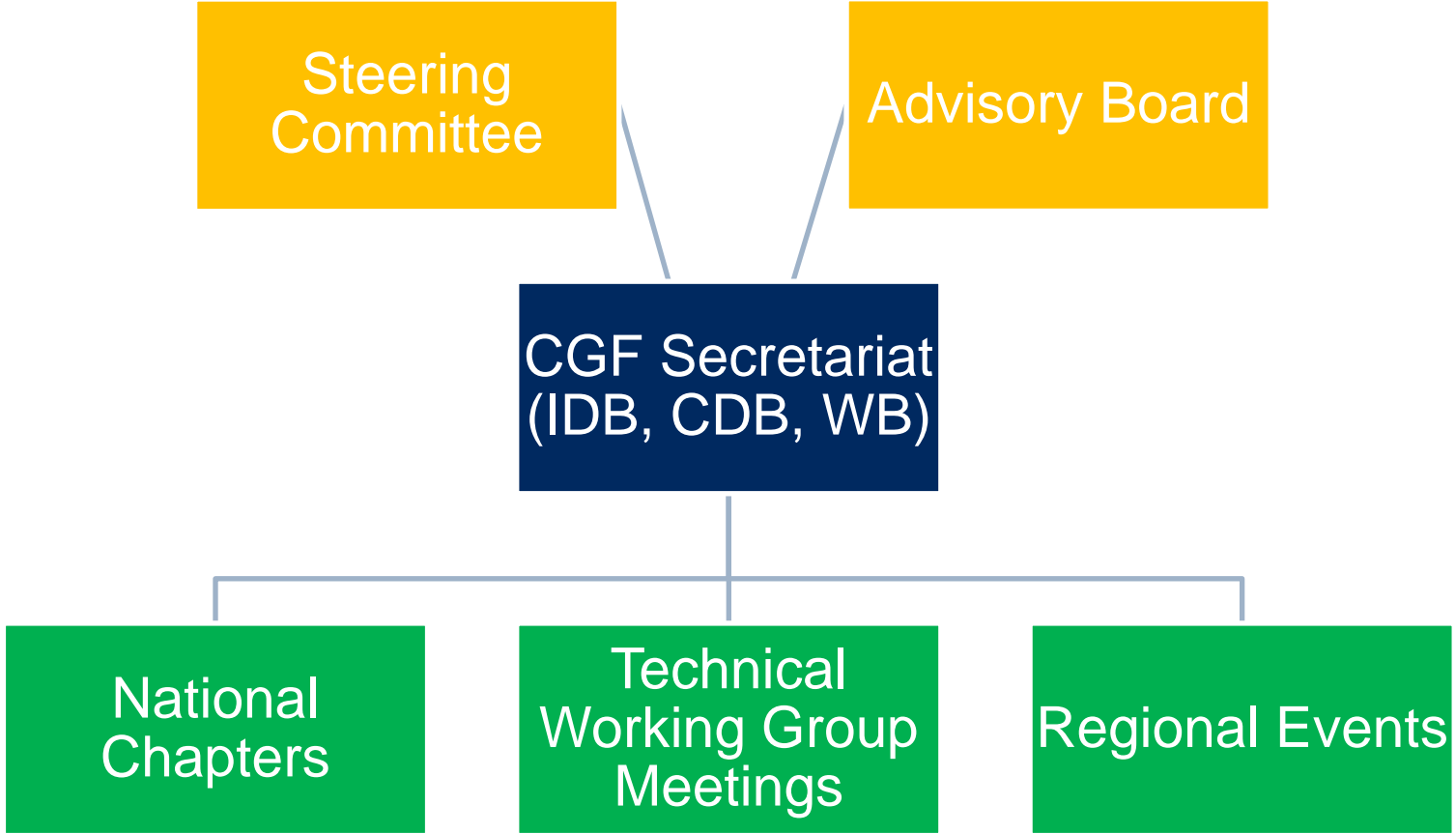


Major milestones along the CGF Journey

What were the positive impacts?

- ***Generating and disseminating knowledge*** to support reform implementation in the three thematic areas
- Supporting ***prioritization of government reforms*** and setting a more focused reform agenda
- ***Strengthening government accountability***
- Giving a ***voice to a range of stakeholders***, particularly private sector and civil society representatives



What could we have done better?

- 1 Define reforms clearly, with realistic timelines and associated performance indicators**
 - For each prioritized reform we will develop a **detailed work plan** and **identify key performance indicators** to measure success
- 2 Include structured feedback mechanisms to help assess reform implementation**
 - Continue to support the **launch of a Private Sector Observatory** to capture feedback from the private sector and ensure accountability
- 3 Enhance continuity of stakeholder involvement throughout the process**
 - Implement a **structured and regular series of communications**, both in person and electronically
- 4 Prioritize reforms to bring greater focus and attention**
 - **Focus on priority areas** and apply a set of **prioritization criteria** with the aim of moving ahead with **five reforms** initially

2 Support the launch of the Private Sector Observatory (PSO)

Role of the PSO

- Provide **independent monitoring mechanism** of the CGF Action Plan and Government competitiveness reform
- Contribute toward **constructive dialogue on corrective measures** in the reform implementation processes
- **Propose improvements to the reform process** based on the results of independent analysis
- **Progress report** in collaboration with CGF and Government focal point

Mandate of the PSO

- **Build partnerships** within the private sector
- Achieve **consensus on measurement indicators** for monitoring
- Undertake **monitoring on the three thematic areas**
- **Continuous dialogue** and communication with key focal points on monitoring findings
- **Joint agreement on corrective actions**

4 And individual reforms will be assessed against the four prioritization criteria

Funding

Extent to which reforms are fully funded or funding sources have been identified

Time to implementation

Expected timeframe to implementation and possibly even to impact (which may be delayed)

Complexity

Technical complexity of the reform or the number of stakeholders required to participate in the implementation

Impact

Scale of potential impact or number of beneficiaries who would benefit

Validation of the reform roadmap with key stakeholders in the first month following the launch

Monthly newsletters to all CGF participants to report on progress and regular updates to the inter-ministerial committee on reforms

In-person check-in meetings with stakeholders every other month

Support to the Private Sector Observatory to get it officially launched
